

# A smarter way to pay for smartphones, tablets and more

Low monthly payment installment plan with no financing fees.\*

## EQUIPMENT INSTALLMENT PLANS

1. Choose a qualified device: Smartphone, Feature Phone (Basic/Quick Messaging), Tablet, Connected Wearable, Mobile Hotspot Device, AT&T Wireless Internet, or Camera. (Tax on sales price due at sale.)
2. Choose Equipment Installment Plan 24 or Equipment Installment Plan 36 for your device and activate the device with qualified wireless service.<sup>1</sup>
3. Make an optional down payment at the time of purchase to lower your monthly installment payments.
4. Make 24 or 36 installment payments, depending on your selected Equipment Installment Plan<sup>2</sup> – the sales price of your device (less any down payment) is divided into equal monthly installments and added to your bill.

<sup>1</sup>If you cancel your service for any reason, your remaining device balance is due.

<sup>2</sup>You can choose to pay off the remaining device balance earlier.

**AT&T EQUIPMENT INSTALLMENT PLANS FOR BUSINESS (EIP): Credit approval required.** Avail. only to business/government customers with a qual. wireless svc agmt (**Business Agmt**). Tax on sales price due at sale. Requires 0% APR 24- or 30-month installment agreement and eligible service. **Down payment:** May be required and depends on a variety of factors. Down payment if required will be 30% of sales price (**amount subject to change and may be higher**). **Examples: For EIP 24** - \$1,099.99 sales price with \$0 down is \$45.83 per month, or with \$330 down (30%) is \$32.08 per month. **For EIP 36** - \$1,099.99 sales price with \$0 down is \$30.56 per month, or with \$330 down (30%) is \$21.39 per month. You may choose to pay more upfront. Remainder of sales price is divided into applicable 24 or 36 monthly installments. **Service:** Eligible postpaid voice and data service is required and extra (minimum \$50 per month for new customers on Mobile Share Plus for Business after AutoPay discount; pay \$60 per month until discount starts within 2 bills. Other qual. plans avail. & existing customers can add to eligible current plans which may be less.) **If service cancelled, remaining device balance is due. Activation/upgrade fee due at sale or billed:** \$30. **Restocking Fee:** Up to \$45. **Limits:** Purchase limit may apply. Eligibility, device, line and financing limits & other restr's apply. See your Retail Installment Agreement for full details.
