Internet connectivity is the lifeblood of your business. But what if your primary internet connection suffers an outage? How will you keep your business running? AT&T Business Wireless Backup Advanced is a fixed wireless solution that provides wireless internet at qualified service addresses for intermittent backup use. It helps keep your business applications up and running if your primary internet connection is temporarily unavailable, so you can stay connected to customers, suppliers, and employees.

Reliable fixed wireless internet

AT&T Business Wireless Backup Advanced is a flexible solution that:

- Helps keep your business up and running when your eligible primary internet connection is interrupted²
- Scales for franchises, multi-site businesses, and enterprise deployments
- Deploys easily and installs in minutes
- Provides unlimited data that can support multiple internet outages per month
 - After 30GB, data speeds are up to a max of 3Mbps and AT&T may temporarily slow data speeds if network is busy. After 7 days of continuous use, AT&T may change or terminate service.

Getting started

AT&T Business Wireless Backup Advanced is available only at qualified service addresses that can support the service. You can only use the service during an outage of your primary internet connection at your designated service address and only on an intermittent backup basis. Prior to purchase, you'll need to specify the desired service address so we can check eligibility and confirm coverage and capacity availability on the local mobile network.¹

In the event of a power outage, AT&T Business Wireless Backup Advanced will work only if a battery backup (sold separately) is installed. Also, AT&T Business Wireless Backup Advanced needs sufficient in-building coverage to work well indoors. The coverage inside your building can be influenced by factors such as the building itself, where the router is placed within the building, the surrounding terrain, and many other factors. We suggest evaluating the coverage at your desired service address before making a purchase.

If your service is cancelled or terminated, you may not qualify to reactivate the service if your location is deemed no longer eligible. When used indoors, plan also requires sufficient in building cellular coverage to work optimally. You should assess whether there is sufficient in building coverage at your desired location prior to purchase. Additionally, AT&T Business Wireless Backup Advanced does not work in the event of a loss of power unless you have battery backup (battery sold separately). **SERVICE RESTRICTIONS:** AT&T Business Wireless Backup Advanced service is intended solely for intermittent, temporary use as a backup connection during an outage of your qualified primary internet service; it may not be used to back up other AT&T wireless or fixed wireless services. **After 7 days of continuous use, AT&T reserves the right to (a) move you to an available AT&T Internet Air for Business plan (see att.com/aibplans) and charge you the corresponding monthly amounts or (b) terminate your AT&T Business Wireless Backup Advanced service.** Additionally, you may not use AT&T Business Wireless Backup Advanced at any address other than your designated service address without AT&T's express prior written approval. You can request eligibility review/approval for a service address change by calling 800-331-0500 or by contacting your AT&T account representative. **If you use the service at a different location without such approval, the service may not operate as intended, and AT&T reserves the right to (a) move you to an available AT&T Wireless Broadband plan (see att.com/awbplans) and charge you the corresponding monthly amounts or (b) terminate your AT&T Business Wireless Backup Advanced service.** AT&T will notify you prior to taking action to enforce either of these service restrictions. **DEVICES:** Each plan is limited to one CRU line and requires a qualified, data-only wireless router (sold separately) supporting business applications. **PRICING:** Monthly pricing includes a monthly plan charge (\$30) for wireless data service. **OTHER RESTRICTIONS AND FEES: Activation/upgrade fee** per line (up to \$50) and deposit may apply. If you purchased a device that requires a service term commitment, an **Early Termination/Cancellation Fee** of up to \$750 applies if you cancel service after the first 30 days and before your service term ends. See att.com/equipmentETF for details on what fee may apply for your device and how the fee is prorated over time. Credit approval may be required. AT&T reserves the right to suspend or terminate service to your account pursuant to your Business Agreement and/or place any noncomplying device on an appropriate plan. **ADDITIONAL AT&T FEES AND GOVT. TAXES:** Monthly AT&T fees apply per line and include Regulatory Cost Recovery Fee (up to \$1.50), Administrative Fee (up to \$1.99), Property Tax Allotment Fee (\$0.20-\$0.45) and other AT&T fees which are not government-required. Tethering/mobile hotspot use is allowed with compatible devices. **DATA RESTRICTIONS: After 30GB of data usage in a bill cycle, then for all data usage during the remainder of the bill cycle, data speeds are up to a max of 3 Mbps & AT&T may temporarily slow data speeds if the network is busy.** **DATA SPEEDS:** The speed of AT&T Business Wireless Backup Advanced service is very dependent upon the connection your wireless router can achieve with the AT&T mobile network. Many things can affect the availability and quality of your service including, but not limited to, your proximity to the cell site, the position of your device within your location, local congestion caused by use of network capacity by high numbers of users simultaneously using data intensive applications in the vicinity of the cell tower serving your designated service address, blockage of the signal between the designated service address and the cell tower (caused by objects such as buildings, foliage, etc.), AT&T network management practices, and weather. As such, **performance, experience, and speeds will vary and are not guaranteed.** To maximize performance, you should make every effort to position your router in an optimal position for your location. **VIDEO STREAMING:** AT&T aims to render streaming video in standard definition (max of 2 Mbps for customers on both 5G-enabled devices and rate plans or 1.5 Mbps for other customers) though some video cannot be identified. Sometimes, other content that content providers bundle with streaming video may be impacted and slowed, including downloads. In certain situations, AT&T may deliver video content faster or at higher definition. Details at att.com/videofeature. **5G SERVICE:** Requires a compatible

5G device and a designated service address in a 5G coverage area. Coverage not available everywhere. See att.com/5Gnetwork for details.

5G+ SERVICE: Requires a compatible 5G+ device and a designated service address in a 5G+ coverage area. Coverage available only in limited locations in specific cities.
