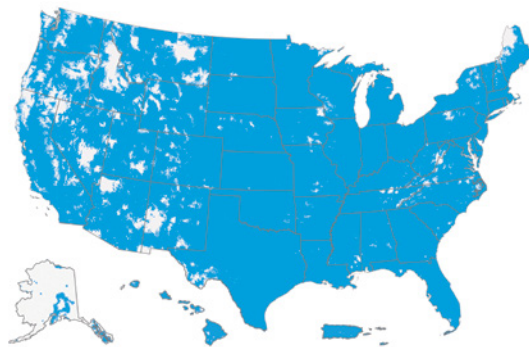

AT&T VOICE PLAN FOR WEARABLES & 250MB DATA FOR WEARABLES FEATURE: All prices are billed monthly and are valid for use in the United States, Puerto Rico and U.S. Virgin Islands (the **Domestic Coverage Area** or **DCA**) only. **Eligibility:** Available only to business and government customers with a qualified AT&T wireless service agreement and only for their Corporate Responsibility User (**CRU**) lines of service. For full service terms and conditions, see applicable wireless service agreement, including without limitation, for business customers, the Additional Service- and Equipment-Related Terms found at att.com/abs-additional-terms (**Business Agreement**). **AT&T VOICE PLAN FOR WEARABLES:** Provides voice and messaging service for use in the DCA. **Night & Weekends Minutes:** 9 pm to 6 am Mon.-Fri.; weekends 9 pm Fri. to 6 pm Mon. **Mobile-to-Mobile Calling:** applies to direct calls to and from U.S. mobile numbers only. International and roaming calls not included. Calls to directory assistance, voicemail, pay-per-use, and call routing and forwarding numbers not included. **Messaging:** applies only to text, picture/video and instant messages sent or received within DCA. **250MB DATA FOR WEARABLES FEATURE:** Required for connected wearables activated on the AT&T Voice Plan for Wearables. Provides data service for use in the DCA. **Data Overage:** If you exceed the total amount of data in your plan during your billing period, additional data will automatically be provided in increments of 250MB at \$5 per 250MB. All data allowances, including overages, must be used in the billing period provided, or they will be forfeited. **INTERNATIONAL:** Monthly plan prices do not apply to calls or texts from the DCA to numbers outside the DCA (international long distance) or to calls, text or data use while outside the DCA (international roaming). Pay-per-use rates apply to such international usage unless you add an eligible international package (sold separately) to the CRU line using the international service. For current international roaming pay-per-use rates, see att.com/intlppurates. For current international long distance calling and texting pay-per-use rates, see att.com/worldconnect. **MISCELLANEOUS:** **Connected Wearable:** Is a wireless phone designed to be worn that is capable of making/receiving calls without being connected to another wireless device. A limit on the number of financed devices per wireless account may apply. **Business Agreement Discounts:** Plan and feature are not eligible for any CRU service discount described in the Business Agreement.

If you purchased a device that requires a term commitment, an **Early Termination/Cancellation Fee** applies if you cancel CRU service after the first 30 days & before the CRU service term ends.
