INSTALLMENT PLAN

1. Choose a device: Basic or Quick Messaging Phone, Tablet, Connected Watches, Mobile Hotspots, AT&T Wireless Internet or Arlo Go (sales tax due at time of sale).
2. Pick an eligible wireless plan. The device retail price is divided into 36 installments and added to your monthly wireless bill.*
3. Pay 36 installment payments to fulfill the agreement.
-OR-
Pay off your installment agreement at any time.

***If you cancel wireless service, your remaining installment balance is due.**

INSTALLMENT AGMT: Limited time only. Credit approval may be required. For eligible tablets, connected wearables, cameras, basic and quick messaging phones, AT&T Wireless Internet and other connected devices. Excludes smartphones. **Tax on sales price due at sale.** Requires 36-month 0% APR installment agreement and eligible service. Divides device retail cost/price into roughly equal monthly installments. \$0 down available for well qual. credit. **Limit as low as 1 device at \$0 down. Down payment:** May be required and depends on a variety of factors. Down payment if required will be either 30% of sales price or a dollar amount ranging from currently \$100 to \$400 (amount subject to change and may be higher). [Examples: Retail price of \$779.99 monthly price for 36 months with \$0 down is \$21.67 per month, with \$234 down (30%) is \$15.17 per month, or with \$400 down is \$10.56 per month.] **Service:** Eligible postpaid voice and/or data service based on device type is required and extra. **If service cancelled, remaining installment agmt balance due. Activation Fee:** \$35/line. **Restocking:** if returned w/in 14 days (or 30 days for select business purchases), fee up to \$55 applies. See att.com/returnpolicy for details. Limits: Eligibility, device, line and financing limits (as low as 1) & other restr's apply. See your Retail Installment Agreement for full details.
