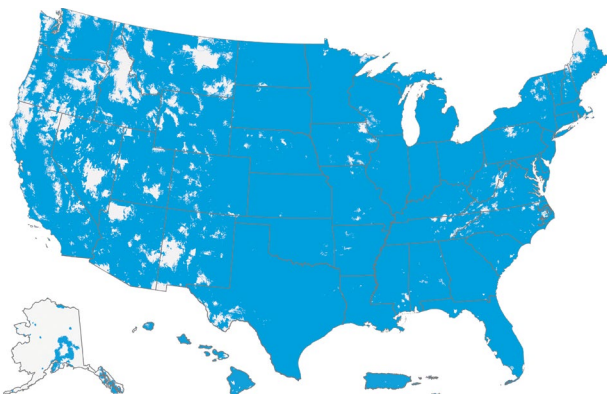

Discount reduced to \$5/mo. per phone line when customer is enrolled in Paperless Billing and Autopay enrolled with credit card. Discount starts w/in 2 bill cycles. Pay full plan cost until discount starts. **SMARTPHONE LINE DISCOUNT:** Advertised monthly price per phone line includes a \$25 monthly discount per line for a smartphone that is purchased at full price, on an installment plan, bring your own, or on a month-to-month term. If eligible, discount is applied as a bill credit. Lines for smartphones with a service commitment are not eligible for this discount. **BASIC PHONE LINE DISCOUNT:** Advertised monthly price per phone line includes a \$25 monthly discount per line for a basic or quick messaging phone (also known as a "feature phone"). If eligible, discount is applied as a bill credit. **OTHER RESTRICTIONS AND FEES: Activation/upgrade fee** per line (up to \$50) and deposit may apply. Credit approval may be required. Coverage available only in very limited parts of select cities. See [att.com/5Gforyou](http://att.com/5Gforyou) for cities. Other restrictions apply. **VIDEO STREAMING:** Plan does not include the Video Management feature. If you exceed the allowance, your service(s) may be restricted or terminated. **MISCELLANEOUS: International Roaming:** Monthly plan prices do not apply to usage while roaming outside the DCA (or, for qualified phones, tablets and Series 5 and higher Apple wearables, outside the DCA, Mexico or Canada).
