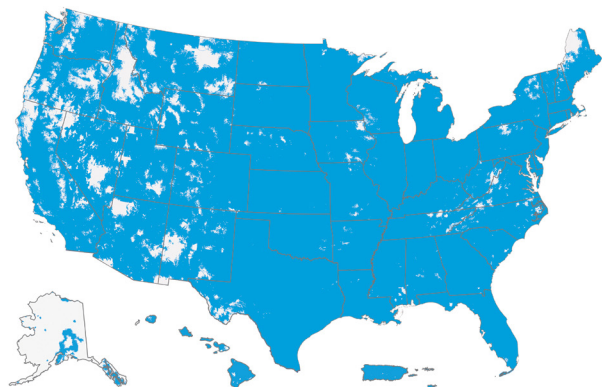

Advertised monthly price includes monthly plan charge for talk, text and data. **Other Non-Phone Device Monthly Charges:** \$20 per tablet; \$10 per wearable. Phone line required to add line for non-phone device. If no phone line, first standalone non-phone device will be billed at basic phone single line pricing (\$70/mo.). If eligible, discount is applied as a bill credit. Lines for smartphones with a service commitment are not eligible for this discount. **BASIC PHONE LINE DISCOUNT:** Advertised monthly price per phone line includes a \$25 monthly discount per line for a basic or quick messaging phone (also known as a "feature phone"). If eligible, discount is applied as a bill credit. **OTHER RESTRICTIONS AND FEES:** **Activation/upgrade fee** per line (up to \$50) and deposit may apply. Credit approval may be required.
