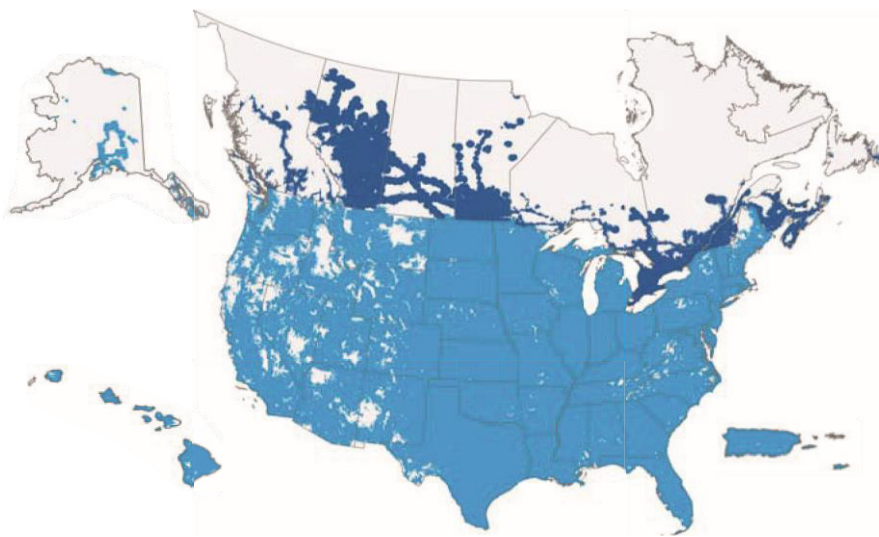

Calls made from or received in Mexico cannot exceed your monthly off-net usage allowance (the lesser of 750 min./mo. or 40% of your Anytime Minutes/mo.) in any two consecutive months. Calls made from or received in Mexico will not qualify as Mobile to Mobile Minutes. Special rates apply for pay-per-use data usage in Mexico. International long distance text, picture and video messaging rates apply to messaging from the U.S. to Mexico, and international roaming rates apply when such messages are sent from Mexico.
